## Notes:

- 1. Based on past records, due to the difference in location and function, the Spring Festival holiday may have a positive or negative impact on the operational performance of the Group's highways. For example, during the holiday period, the traffic volume and toll revenue of the interprovincial channel highways such as Qinglian Expressway, Yangmao Expressway and Guangwu Project are usually at higher levels, while the operational statistics of the highways in the urban peripheral area such as the sections in Shenzhen region usually indicate a trend of lower levels. As the time of Spring Festival holiday differs for each year (2015 Spring Festival: 19 February; 2014 Spring Festival: 31 January), investors are advised to consolidate the operational statistics for both January and February of each year for comparison in order to see the trend of the year-on-year change in operational performance of the projects.
- 2. Day of implementation of the toll free scheme for small passenger vehicles during February 2015: 7 days (February 2014: 6 days). Day of implementation of the toll free scheme for small passenger vehicles during January February 2015: 7 days (January February 2014: 7 days).
- 3. The provincial-wide inter-network toll collection in Guangdong Province has been implemented since the end of June 2014. As the amount of data to be processed is rather large and it takes time for splitting and checking works, certain operational data of the highway projects in Guangdong Province after provincial-wide interconnection shall be recorded based on estimation at the date of monthly settlement and disclosure. Investors are advised to use such data cautiously.
- 4. Pursuant to the relevant approval and authorisation by the general meeting of the Company and Shenzhen government, toll-free for Meilin to Guanlan section of Meiguan Expressway with a mileage of approximately 13.8 km was implemented from 24:00 on 31 March 2014, and the toll for section from Shenzhen-Dongguan border to Guanlan with a mileage of approximately 5.4 km remained. For details of the adjustment, please refer to the announcements of the Company dated 27 January 2014, 28 March 2014 and 31 March 2014. As there is substantial change on the toll mileage, no YOY change data has been provided for this month.
- 5. Guangle Expressway (Guangzhou Lechang) and Erguang Expressway Lianzhou to Huaiji section commenced operation in the end of September and December 2014 respectively, which had certain diversion effect on Qinglian Expressway. In addition, by the negative impact of the factors such as road network changes, the toll revenue of Wuhuang Expressway and Nanjing Third Bridge recorded a YOY decrease in January February 2015.
