- 1. Affected by the slope landslide accident of Longgang to Hengping Section of Shuiguan Expressway, the average daily toll revenue of Shuiguan Expressway and Shuiguan Extension decreased YOY.
- 2. The commencement of the construction of Foqingcong Expressway (Foshan Qingyuan Conghua) which connected to GZ W2 Expressway has caused negative impact on the traffic volume of GZ W2 Expressway to a certain extent. However, since Foshan First Ring Highway is being reconstructed into an expressway, the traffic volume of the whole journey of GZ W2 Expressway has observed a considerable increase. Affected by the above-mentioned factors, although the traffic volume of GZ W2 Expressway Road in November recorded 4.2% decreased YOY, the toll revenue recorded 7.8% increased YOY.
