The board (the “**Board**”) of directors (the “**Directors**”) of Shenzhen Expressway Corporation Limited (the “**Company**”) hereby announces that according to *The Approval on the Registration of Public Issuing Green Corporate Bonds to Professional Investors by Shenzhen Expressway Corporation Limited* (關於同意深圳高速公路集團股份有限公司向專業投資者公開發行綠色公司債券註冊的批覆) (*Zheng Jian Xu Ke [2022] No.559*) (the “**Approval**”) received by the Company in recent days, China Securities and Regulatory Committee (the “**CSRC**”) has approved the registration of public issue of green corporate bonds (the “**Corporate Bonds**”) to professional investors with total nominal value not exceeding RMB4.1 billion by the Company.
